Cat.	Target	Care Description Note
TGC	Education	Other GOAL: Instruct patient and caregivers in side effects of condition, appropriate suggestions for management of decreased sensory, perceptual problems, poor judgment, cognitive changes, mobility risks. TIME FRAME: ongoing during course of treatment.
TP	Mobility/Transfers	Other GOAL: Patient will reach maximum independence with rolling, scooting in supine or sit for ADL's. Instruct caregivers in how to assist yet allow patient to function at their maximum effort as well. TIME FRAME: 12-20 visits.
TP	Mobility/Transfers	Other GOAL: Patient will be able to transfer independently sit to supine, sit to stand, or w/c transfer at highest maximum potential. Ongoing treatment to determine highest level of function possible for toilet, bath, car, floor transfers. TIME FRAME: 4-6 weeks, 2-3x/wk
TP	Mobility/Transfers	Other GOAL: Patient will be independent with w/c mobility indoors, maximum function possible and as necessary for outdoor activity. TIME FRAME: 6-8 visits.
TP	Exercises	Other GOAL: Increase strength of antigravity muscles to good grade working within tone restrictions where present. Patient and caregiver will be independent with exercise routine. TIME FRAME: 4 visits to instruct and then ongoing eval of need to upgrade.
TP	Exercises	Balance Activities GOAL: Patient will have good to normal dynamic sitting balance, maximum level standing balance possible, instruct caregivers of status and carryover to ADL's. TIME FRAME: 2-3x/wk for 4-6 wks.
TGC	Durable Medical Equipment	Other GOAL: Make recommendations regarding appropriate DME and instruct in use as appropriate. TIME FRAME: ongoing
TP	Gait Training	Other GOAL: Patient will be able to negotiate ambulation indoors with appropriate device and highest level of independence possible. Independent with negotiation of stairs and outdoor terrain with device or instruct caregivers if determined that independence is not achievable. TIME FRAME: duration of treatment
